### Registration Rates

All registration fees are subject to applicable taxes based on the province of residence of the registrant.

The Annual General Meeting (AGM) registration entitles participants to the following:

- Access to all main platform and workshop sessions during the AGM and on demand for a limited period of time following the AGM
- All participant materials
- Applicable continuing education credits.  
Only registered members and guests are eligible for CE credits.

The AGM fee does not include any other expenses that may be incurred by delegates.

CALU members who are presenting are required to register as full AGM registrants and pay any applicable fees.

Guests who apply to become CALU members within 3 months of the AGM (by August 1, 2021) will be eligible for a 10% discount on their 2021 membership fee.

### Registration Payment

All registration fees must be paid online by Credit Card (VISA or MasterCard) at the time of registration. Registrations will not be processed or confirmed until payment is received in full. Any bank charges for disputed credit card charges must be paid by the registrant and not CALU.

CALU will send via e-mail a confirmation of AGM Registration and acknowledgement once full payment has been received and processed.

### Cancellations

Due to the virtual nature of the event and the on-demand access of all conference sessions after the event, cancellations and transfers are not permitted.

#### Alterations to the AGM Program:
